

Tentative Agreement
California School Employees Association and its
Chapter #506
And the
Riverside Unified School District

The parties agree that it is in the interest of the Riverside Unified School District (District) and California School Employees Association and its Riverside Chapter #506 (CSEA) to have stability during the period in which the parties negotiate. To this end the parties agree as follows:

1. The parties agree to create a new Collective Bargaining Agreement between CSEA and the District with a term of July 1, 2018, through June 30, 2021. This will change the Collective Bargaining Agreement dates located in Article XXII – Miscellaneous Provisions.
2. The above referenced Collective Bargaining Agreement shall embody all of the specific terms of the agreement that expired on June 30, 2018, with the exception of the duration of the new Collective Bargaining Agreement located in Article XXII – Miscellaneous Provisions.
3. The parties agree that they will public notice (pursuant to EERA Section 3547) their respective proposals for negotiations (other than the term) no later than September 19, 2018. The parties agree to commence negotiations on these proposals no later than September 30, 2018.
4. Pursuant to the provisions of this agreement, the parties shall have a free and unlimited right to make negotiation proposals on any subject matter within scope, with the exception of the previously determined duration of the new Collective Bargaining Agreement located in Article XXII – Miscellaneous Provisions.
5. Nothing in this agreement shall be construed as limiting any rights the parties otherwise retain under the provisions of the Educational Employment Relations Act.

This agreement is subject to CSEA Policy 610 and ratification from the CSEA membership and the approval of the Board of Education.
