BASIC FUNCTION:

Under direction of the Director, Maintenance, Operations and Transportation, plan and organize grounds and centralized custodial services. The duties consist of but not limited to greenscape renovation and maintenance; irrigation design, installation and maintenance; hardscape repair; District-wide custodial service; administrate district's Integrated Pest Management program and develop and maintain quality control standards for all responsible areas.

REPRESENTATIVE DUTIES:

- Plan, organize, direct and control the functions of the Grounds and Custodial Department.
- Inspect, review, and evaluate the performance of custodial and grounds personnel.
- Work cooperatively with other Maintenance and Operations managers on large, multi-trade projects.
- Effectively communicate both verbally and in writing with a variety of District personnel regarding all aspects of the grounds and custodial operations.
- Arrange and supervise new planting, transplanting, and removal or preconditioning of shrubs, lawns, trees and the removal and disposition of debris from landscaped areas.
- Supervise the application of pesticides and herbicides in accordance with the Safe Schools Act of 2000.
- Oversee the Install, repair, care and operation of irrigation and sprinkling systems.
- Provide operational oversight to the district's centralized irrigation control system.
- Supervise the layout of athletic fields and other landscaped areas.
- Maintain, update and construct turf and landscape plans for all District facilities.
- Assure compliance with applicable Federal, State and District safety codes and regulations.
- Oversee the repairs to mechanized equipment related to grounds, custodial and waste management.
- Manage assigned budget.

- Develop and implement orientation and in-service training programs for custodian and grounds personnel.
- Recommend the purchase of supplies, material and equipment used in the custodial and grounds maintenance functions.
- Read and review construction documents and plans.
- Schedule and inspect the work of contractors on major and minor construction projects.
- Select, supervise and evaluate represented staff.
- Ensure that all playground equipment and fixtures are in proper repair.
- Prepare written reports for supervisor or regulating agencies.
- Report work progress to supervisors, inspect and correct the work of all trades personnel as necessary.
- Administrate district waste management program and ensure that waste reduction goals are being met.
- Perform related duties as assigned.

KNOWLEDGE AND ABILITIES:

- Types, characteristics, and recognition of various flowers, plants, lawns, shrubs, and trees
- Characteristics of soils and fertilizers
- Common plant diseases and pests
- Installation, repair and service of automated sprinkling systems
- Methods, materials, and equipment used in the maintenance, installation, repair and maintenance of asphalt-concrete paving
- Methods and materials utilized in the installation, repair and maintenance of chain link fencing
- Licensing and codes regarding proper operation and loading of trucks
- Industrial safety regulations
- Various software applications including but not limited to: Microsoft Word, Excel, Power Point, Outlook, and Auto CAD
- Cleaning methods and techniques
- Cleaning standards for schools
