Riverside Unified School District adopts instructional materials on a regular schedule based on State adoptions. All students receive appropriate, up-to-date instructional materials for use in the classroom and at home. All materials currently in use have been

Professional Development (Most Recent Three Years)

During the 2014-2015 school year, all teachers and administrators at Washington participated in multiple sessions of professional development training in an effort to increase their capacity and knowledge of language arts and mathematics instruction. The topics and initiatives were selected after conducting a needs assessment that included achievement data, and a survey of the leadership team based on their team's feedback. Training was offered during the instructional day, in after school sessions both paid and voluntary, as well as Saturday training, and Summer Institutes.
